Continuation of this type of behavior could result in a request by the Mayor that the individual leave the meeting, and if refused, an order of removal. In compliance with the Texas Open Meetings Act, no member of City Council may deliberate on citizen comments for items not on the agenda. (Attorney General Opinion JC 0169)

- 8.2. Discussion/Action: Resolution 2025-3-1, Order of Special Election. Consider and take possible action on a stated resolution ordering a special election on May 3, 2025, for the City of Cumby, Texas, to submit to voters a proposition to adopt a local sales and use tax rate of 1.5% making the total tax rate for the City 8.25%. *This will be a .25% increase in the local sales tax.* The current state sales tax rate is 6.25%, the current city sales tax rate is 1.25%, and Hopkins County has a .5% sales tax making the current total local sales and use tax 8.0%. The revenue from the increase will be used for infrastructure improvements, essential city services, and economic development. (Mayor Hardy, City Secretary)
