- B) Maintenance Department

- C) Volunteer Fire Department

Report given by Tommy Faulknor had 13 medical calls, 7 motor vehicle accidents, 1 car fire, 1 structure fire, 5 grass fires, 2 investigations/standbys. There were 14 calls in the City and 17 in the district.
