3. PRESENTATION BY CITIZENS

The City Council welcomes "Presentation by Citizens." If you wish to speak, you must follow these guidelines
Presentation by Citizens Guidelines:

- The Mayor will recognize those citizens who have signed up prior to the start of the meeting.
- Pursuant to Resolution No. 2020-12 Citizens are given three minutes (3:00) to speak during "Presentation by Citizens."
- Members of the public may only speak once and cannot pass the individual's time allotment to someone else.
- Direct your comments to the entire Council, not to an individual member.
- Show the Council members the same respect and courtesy that you expect to be shown to you.
- The Mayor will rule any disruptive behavior, including shouting or derogatory statements or comments, out of order. Continuation of this type of behavior could result in a request by the Mayor that the individual leave the meeting, and if refused, an order of removal. In compliance with the Texas Open Meetings Act, no member of City Council may deliberate on citizen comments for items not on the agenda. (Attorney General Opinion – JC 0169)

4. CITY COUNCIL COMMENTS

Pursuant to TEX. GOV'T CODE 551.0415, the Mayor, a City Council member and Staff may report on the following items of community interest:(1) expression of thanks, congratulations or condolences (2) information about holiday schedules (3) recognition of individuals (4) reminders about upcoming events organized or sponsored by the City Council (5) Information about community events and (6) announcements involving imminent threat to public health and safety. Additionally, pursuant to TEX. GOV'T CODE 551.042, the Mayor or Council members may request that items be placed on future City Council agendas.

6. NEW BUSINESS

6.1. **Discussion/Action:** Consideration and possible adoption of Ordinance No. 2025-09-01 creating the Office of City Administrator; providing for appointment by the City Council; prescribing duties and administrative authority; assigning certain City Secretary functions (custodian of records, records management, public information, and elections administration) excluding agenda preparation and council minutes; establishing contract/purchase authority up to a certain amount; requiring monthly operational reports; and providing an effective date. (Mayor Pro Tem, Alderman 5)

6.2. **Discussion/Action:** Discussion regarding possible purchase of Nixle. Nixle a communication system used by public safety agencies to send real-time alerts and information to residents. It allows agencies to share critical updates like severe weather warnings, evacuation notices, boil water notices, and other public safety information via text message, email, web, or mobile app. Residents can subscribe to Nixle to receive these alerts, often by texting their ZIP code to a designated number, like 888777. Annual cost is \$3003.00 with a 36-month contract. (Chief Hackney)

7. OLD BUSINESS

- 7.1. **Discussion/Action:** Update on various grants and other potential funding requests by City of Cumby
- Park – Grant is good for another year, the city has decided to hold off until we are more financially sound before we try to take on that match grant.
 - Wastewater Treatment Plant – Clarifier is currently being pumped, and the project is estimated to be completed withing the next 8-10 weeks.
 - The City did not qualify for the recent round of TWDB grants for the wastewater and water enhancement grants
