## 4. PRESENTATION BY CITIZENS

The City Council welcomes "Presentation by Citizens." If you wish to speak, you must follow these guidelines Presentation by Citizens Guidelines:

- The Mayor wil recognize those citizens who have signed up prior to the start of the meeting.
- Pursuant to <u>Resolution No. 2020-12</u> Citizens are given three minutes (3:00) to speak during "Presentation by Citizens."
- Members of the public may only speak once and cannot pass the individual's time allotment to someone else.
- Direct your comments to the entire Council, not to an individual member.
- Show the Council members the same respect and courtesy that you expect to be shown to you.
- The Mayor will rule any disruptive behavior, including shouting or derogatory statements or comments, out of order. Continuation of this type of behavior could result in a request by the Mayor that the individual leave the meeting, and if refused, an order of removal. In compliance with the Texas Open Meetings Act, no member of City Council may deliberate on citizen comments for items not on the agenda. (Attorney General Opinion JC 0169)

#### 7. NEW BUSINESS

- 7.1. Discussion/Action: Adoption of Ordinance 2025-11-20, Authorizing Signatories on City of Cumby Bank Accounts. Proposed Authorized Signatories: Mayor, City Administrator, 1 Alderman, Chief of Police, and one (1) additional signatory (if any), to be determined during this meeting. (City Administrator)
- 7.2. Discussion/Action: Council consideration and approval to rename the existing ARPA account to "Volunteer Fire Department- Pumper Truck" This change will allow the City to transfer and manage designated funds separately from the general accounts, ensuring clarity, transparency, and proper financial reporting. (City Administrator)
- 7.3. Discussion/Action: Consider and take possible action on Ordinance No. 2025-12-01, establishing residency restrictions for certain registered sex offenders within the City of Cumby, Texas.

The City of Cumby seeks to implement a municipal ordinance designed to enhance child safety by restricting where certain registered sex offenders may establish residency within city limits. Pursuant to Texas Local Government Code § 341.906, municipalities are authorized to create "Child Safety Zones" around locations where children commonly gather, including schools, parks, daycare centers, playgrounds, and similar facilities. The proposed ordinance prohibits certain registered sex offenders—specifically those whose offenses involved a victim under the age of 17—from residing within 1,000 feet of designated child safety locations. The ordinance includes required statutory exemptions, such as for individuals who established their residence prior to the ordinance ("grandfathered") and those placed or supervised by state authorities. (Chief of Police)

- 7.4. Discussion/Action: Consider and take possible action on Ordinance No. 2025-12-02 establishing a regulatory framework and fee schedule for 8-liner gaming machines, game rooms, and 8-liner operation within alcohol-selling establishments in the City of Cumby. The City has drafted a comprehensive ordinance regulating 8-liner amusement machines, game room permits, alcohol-premises compliance, nspections, and enforcement. The ordinance is drafted pursuant to Texas Penal Code Chapter 47, the Texas Alcoholic Beverage Code, and municipal police powers. (Chief of Police, City Administrator)
- 7.5. Discussion/Action: Discussion and possible action regarding approval of a Contract for the Collection of Delinquent Municipal Court Fines and Fees between the City of Cumby, Texas and McCreary, Veselka, Bragg & Allen, P.C. (MVBA). (City Administrator/John Morris, MVBA)

- 7.6. Discussion/Action: Discussion and possible action regarding interagency coordination and administrative matters involving the Cumby Police Department. The City of Cumby and the Cumby Police Department are evaluating opportunities to strengthen intergovernmental cooperation, enhance public safety resources, and improve operational readiness. This item allows the City Council to consider any administrative actions, agreements, or directives related to interagency partnerships or support functions that may arise from ongoing assessments and consultations.
- 7.7. Discussion/Action: Resolution Appointing a member for the Hopkins County Board of Directors representing Hopkins County for the term beginning January 1<sup>st</sup>, 2026 and ending December 31<sup>st</sup>, 2027 (City Administrator)
